History

The International Institute of Metropolitan Detroit [IIMD] was founded as a movement in 1919 by Edith Terry Bremer, a Social Worker involved in the Women's Trade Union League and the Settlement Movement.

Ms. Bremmer believed that immigrants were underserved by traditional welfare agencies and created the first International Institute in New York City- founded on the principle that immigrants are best served by immigrants. Thus, IIMD was among the first of 55 International Institutes located in urban areas thoughout the United States.

IIMD transforms the lives of low-income immigrants and U.S. born Detroiters through innovative solutions leading to economic mobility.


This mission is lead on founding core values: 1. Service; 2. Committment; 3. Inclusion; and 4. Imapet.

PROGRAM HIGHLIGHTS

COVID-19 Rapid Response

Center for Working Families

- 150 Food Boxes Distributed
- 120 low-income households provided with utility assistance
- 110 low-income individuals provided with mortgage and rental assistance
- 60 low-income indivduals provided with \$500.00 cash assistance
- 90% of job seekers received living wage employment
- 80% of job seekers earned increased wages
- 85% of participants increased their credit scores
- 95% of participants received a new state benefit, [e.g., unemployment insurance, etc.]

Adult Education

- 90% of students advanced two grade levels
- 85% of students successfully completed the program
- 70% of students enrolled in IIMD's Occupational Training program
- 65% of students enrolled in the Occupational Training program received Certified Nursing Assistant [CNA] credential

Legal Immigration Services

- 95% of all Legal Immigration clients received their naturalized citizenship
- 85% of legal immigration clients received adjustment of status
- 70% of all family reunification cases were successfully reunified with their families

Community Development

- IIMD and its partner, the Islamic
 Center of Detroit held 8 communitywide planning session
- 100 1:1 meetings were held with community leaders
- 12 Internal Planning Sessions were conducted
- 45 survey responses were completed
- A comprehensive report was conducted

Entrepreneurship Training

- 20 students enrolled in the training
- 85% of students successfully passed the training program
- 80% of students successfully opened a small business
